## WIXOM COMMUNITY FOUNDATION

In 1996, the Wixom Community Foundation was born out of the City of Wixom Endowment Trust to assist the philanthropic interests within the community. In 2009, the community leaders conceived the concept of a non-profit community foundation as a means to address the needs of the individual, family and community. Through the creation of the IRS 501(c)(3) corporation, cultural, educational, beautification, historic preservation, public building, recreational, human services and other charitable / philanthropic initiatives could be pursued. On September 8, 2009, the Wixom Community Foundation appointed its first Board of Directors and the By-Laws were adopted on October 15, 2009. The Foundation received its 501(c)(3) status in July 2010.

In addition to assisting the needs of the community, the Foundation will also focus on the establishment of a long lasting relationship with both corporate and individual residents of the City. It will bring people together with a highly personal approach to giving, contributing toward a vibrant healthy community for future generations and will become a permanent part of a lasting endowment.
